#### 1. Duration and Place of the exhibition

ICARUS 2008 will take place in Athens at the fairground of TATOI (airport), from Friday, June 13th to Sunday, June 15th, 2008. The exhibition will open on Friday and Saturday from 11:00 am to 19:00 p.m Greek time. On Sunday from 10:00 am to 19:00 pm Greek time. The right to alter the opening time is reserved. Such changes will be announced always in good time. Every day after the end of the exhibition (19:00), the exhibition must leave the exhibition ground within one hour until 20:00. After the end of the exhibition (15/6), all the exhibitors are obliged to give back their stand empty till June 16th 2008 (19:00).

#### 2. Admission

Admitted are all the companies whose exhibited products correspond to the subject of the exhibition or are relevant with it. Moreover, the companies which are responsible for the transfer, the food, the stay and the communication of the exhibitors/visitors are also admitted. The confirmation of the registration will be decided from the host company and will be confirmed in writing.

#### 3. Application & Confirmation

The registration form (of participation) must have the form that is enclosed in the folder of the exhibition and can also be found on the official website of the event. It shall be fully signed with legally binding signature and sent as soon as possible to Hellas Fest (Address-23 Alatsaton, P.C. 14231, N.Ionia, Athens, Greece, tel 0030 2102716601, fax 0030 2102716664, e-mai expo2008@icarusaeroexpoathens.gr).

Applications after May 25th will not be accepted. With your signature you agree with the general and the special terms of participation. Your data are confidential and will be stored regard to the provision of the article 2472/97 which regulates the protection of data. The signed application form is binding. Upon receipt of your application you will receive a written confirmation of the host company and your stand-site. The exhibitor is obliged to exhibit specified products and keep the stand occupied for the entire duration of the exhibition. Prior to accepting other companies or products at your stand you will need the consent of HELLAS FEST. Due to special circumstances it might be necessary to relocate your stand, to alter the size and dimensions of reserved space, to change entrances, exits and corridors or to make structural changes even after you have received a confirmation of your stand.

#### 4. Exhibits

The application form must contain the exhibited products. Exhibits that are not included can be removed from the stand by the host company after the opening of the exhibition and at the exhibitor's cost.

#### 5. Official Regulations

Under the terms of Greek Official Regulations the price of the products must be clearly shown on the exhibit or in a price list that is visible to the visitors/buyers. Where open food and drink are offered for sale, the stand must be equipped with a water supply and wastewater outlet. In addition, persons serving food and drink must be in possession of a valid official Health Certificate. The use of liquid gas equipment in the exhibition halls is also prohibited.

#### 6. Booking and assignment of stands

HELLAS FEST will endeavour to satisfy wishes regarding location and size of the stand considering the arrangement. Due to the arrangement of the internal and external fairground, the allocation of stands will be based on the date that the application is submitted. Deviations are to be expected for technical reasons. The minimum stand area is 15 sqm for the internal fairground and 20 sqm for the external one.

#### 7. Cancellation

Cancellation is possible 2 months before the opening of the exhibition and it is free of charge. Cancellation 40 days before the event will cause the following fee: 50% of the invoice total. Cancellation 1 month before the event will cause the following fee: 100% of the invoice total.

#### 8. Stand construction/technology

The construction of the stands can only be made by HELLAS FEST or its immediate partners. Plans, materials, telephone and internet link must be sent to HELLAS FEST until April 30, 2008. Stands exceeding the standard height of 2.5 meters or special constructions must be approved by the host company. The relaying of music at exhibition stands or the use of andio-visual resources using sound systems must be approved by HELLAS FEST.

#### 9. Other Charges

All the other charges apart from the basic provisions are based on published price lists, as well as on deals between the host company and the exhibitor that are proved with official tax documents (invoices). The cost of telephone calls is not included and will be charged after the end of the exhibition. Foreign exhibitors (companies) can have the value added tax they have been charged reimbursed if the appropriate legal requirements are fulfilled. Failure to comply with the terms of payment and to meet deadlines may lead to exclusion from the exhibition and invoicing of any expenses incurred plus default interest at the customary bank rates.

#### 10. Forms & Documents

All order forms can be downloaded under the official website of the exhibition or can be sent to you after an application to expo2008@icarusaeroexpoathens.gr.

#### 11. Verbal agreements

Verbal agreements over and above the scope of the present contract are enforceable only if they have been confirmed in writing by the host company of the exhibition.

#### 12. Obligations

- 12.1 The exhibitor shall be obliged to comply with the relevant laws of labour, trade, fire protection, accident prevention regulations and the provisions of competition law.
- 12.2 The exhibitor shall continuously monitor compliance with the above-mentioned regulations by his personnel or his other agents. In the event of an infringement of this obligation, the exhibitor shall inform immediately the host company.
- 12.3 All the exhibitors should have liability and insurance not only for their personnel but also for their stand in the exhibition ground.
- 12.4 By submitting the application form, the exhibitor hereby agrees to his personal data being recorded, processed and used for the purpose of organizing the event and for purposes of advertising, market research or opinion research? in accordance with the latest version of the Data Protection Act.
- 12.5 The exhibitor shall also be obliged to take part in electronic visitor recording and evaluation programmes, and shall agree to the publication of information relating to his participation via electronic media, including the Internet.
- 12.6 If an exhibitor fails to comply with his payment obligations, the host company may exercise his right of lien, retain the exhibits and the stand fittings, and have them auctioned at the expense of the exhibitor, each time after prior written notification, or to sell them privately if they have a stock exchange price or a market price.
- 12.7 Non-participation by the exhibitor shall not generally release him from his contractual obligations. The exhibitor shall be obliged, in particular, to pay the contractually due fees. The host company shall not be obliged to accept a replacement exhibitor nominated by the exhibitor.
